1-year autorenewal subscriptions will automatically be renewed at the end of every subscription period, until the subscriber cancels their subscription. The minimum subscription period is one year for both subscription types.

2. Service content and system requirements

The digital edition at ark.fi is a browser-based version of the printed *Finnish Architectural Review*. The service does not comprise any supplements to print subscription of *Finnish Architectural Review*, such as *Architectural Competitions in Finland (Arkkitehtuurikilpailuja)* – which is, however, available online at SAFA's website elsewhere.

Accessing the full digital edition requires subscription for the service and an ongoing Internet connection. Full magazines cannot be downloaded or saved on personal computers. The service does not include the right to copy the content of the magazines's pages or print the magazine without restrictions.

The reader is responsible for having an internet access fast enough for using the service, and a device with a browser suitable for reading the digital content.

3. Subscribing the service

The use of the service requires subscription and the creation of user account. Print edition subscribers receive their digital access credentials with their invoice and order confirmation. Digital subscribers are required to create user accounts when making the subscription when making the online payment.

The username and password are personal to the user and their immediate family, and may not be assigned to a third party. If the customer is a company or corporation, the credentials may be used by several people at the workplace or work computers, but not on home computers.

Public institutions, such as libraries and educational institutions, must hide the username and password from public users.

These terms are also applied to the members of SAFA and the subscribers of *Finnish Architectural Review* who are automatically entitled to read the digital edition.

4. Forms of purchase and subscription

The digital edition may be subscribed to in periods of 1, 6 or 12 months or with print subscriptions.

Printed magazine

The printed *Finnish Architectural Review* can be subscribed to on the magazine's website or by contacting the magazine subscriptions service. The order is processed in 2-5 weekdays. The subscription of the printed magazine always includes access to the digital edition. Single print copies of *Finnish Architectural Review* can be inquired by email subs@ark.fi or by using a digital form on the website (<https://www.ark.fi/en/subscribe/order-back-issues>).

Digital subscription

The digital edition may be subscribed to in periods of 1, 6 or 12 months. During the subscription period, the customer has the right to read all the magazines and content available on the ark.fi web service, including new issues published during the subscription period as well as older issues in the digital archive. When the subscription ends, the right to read any content on the service ends as well. Digital subscriptions can be purchased directly online. If online order is not possible, digital subscriptions can also be invoiced by contacting subs@ark.fi, in which case the order is processed in 2-5 days.

Single digital issues bought before 27 November 2019

Before 27 November 2019 the previous version of the ark.fi website offered for sale digital single issues of the magazine. The technical support for accessing these issues has ended. However, the magazine will honor such previous proven purchases case by case. For support, customers can contact subs@ark.fi.

5. Payment methods

Print subscriptions are charged by an invoice emailed to the customer.

Digital subscriptions are paid for by credit card, mobile payments or online bank transfer. The party implementing the payment gateway and acting as the payment service provider is Svea Payments Oy in cooperation with Finnish banks and credit institutions. Card and mobile payments

Major credit cards and some mobile payments are accepted. The party receiving the payment is Svea Payments Oy, which will transfer the payment to the seller. Svea Payments Oy is a licensed payment institution.

Online bank payment

Payment can be made using online banking credentials issued by Finnish banks.

6. Value added tax (VAT)

Companies and corporations liable to pay value added tax pay for annual and standing subscriptions according to the tax rate of their country, and the reverse charge mechanism for value added tax can be applied. Consumers and parties purchasing subscription can be charged the value added tax valid for magazines in Finland regardless of the customer's form of enterprise or domicile. The amount of VAT is calculated in the order or invoice.

7. Service limitations

Termination of subscription due to a breach of the terms of use

The Finnish Association of Architects is entitled to disable a customer's account in the event that the customer fails to pay the subscription invoice or there is a justifiable reason to assume that the account has been used in a manner that breaches the terms of use (e.g., provided to third parties for their use). If the account is disabled due to a breach of the terms of use, previously paid subscription fees will not be refunded.

Termination of the service

Using the digital edition service is possible as long as the service is being provided. In the event that the service is discontinued and the customer loses the right to read digital content (or previously purchased content), the Finnish Association of Architects shall give the customer a discount on the purchase price of the corresponding printed issues or may find a case-by-case digital solution.

Technical problems

The Finnish Association of Architects is not responsible for ensuring that the customer's equipment and software are suitable for reading the digital edition.

Due to technical reasons, images are may be displayed differently in the digital edition as they do in the printed version. The Finnish Association of Architects shall not refund the price of a subscription or single copy in the event that the customer complains about the accuracy of images.

Technical reasons (such as software updates) may cause service interruptions. The Finnish Association of Architects is liable to compensate any interruptions lasting longer than one week, in which case the subscription period can be extended by a period corresponding to the interruption.

Copyright and Republishing Rights

Any material published in the print or digital editions of the magazine is subject to the Copyright Act. No type of reissue is allowed without the permission of the publisher. For any requests related to copyrights or republishing contact the editorial office.

8. Disputes

Any disputes arising out of this agreement shall be settled at the District Court of Helsinki.
